

**Long-Stay Visa 'O-A'**  
**(Non-Immigrant Visa O-A)**

**1. Qualifications for the Applicant**

1. An alien being 50 years of age and above (on the date of submitting an application)
2. Not being a person prohibited from entering the Kingdom.
3. Having no criminal record against the security of Thailand and the country of his/her nationality, or the country of his/her residence.
4. Not having prohibitive diseases as indicated in the [Ministerial Regulation No. 14 \(B.E. 2535\)](#) (Leprosy, Tuberculosis (T.B.), Elephantiasis, Drug Addiction, Alcoholism, Third step of Syphilis)
5. Having the nationality of or the residence in the country where his/her application is submitted.
6. Not being allowed to work in Thailand

**2. Documents for the Applications**

1. A passport valid no less than one year and a half
2. Four completed and signed **Visa Application Form** (attached with one photo for each visa application form).
3. A **Personal Data Form**
4. A copy of a bank statement showing a deposit at the amount equal to ***no less than 800,000 Baht***, or an income certificate (an original copy) with a monthly salary of no less than 65,000 Baht, or a deposit account plus monthly income of no less than 800,000 Baht a year.
5. In the case of the bank statement, ***a letter of guarantee from the bank*** (an original copy) is to be shown as well.
6. Verification stating that the ***applicant has no criminal record*** issued from the country of his/her nationality or residence (the verification shall be valid for no more than 3 months).
7. A ***Medical certificate*** issued from the country where the application is submitted, showing no prohibitive diseases as indicated in the Ministerial Regulation No. 14 (B.E. 2535) (the certificate shall be valid for no more than 3 months)
8. In the case that the applicant wishes to have his/her spouse stay together in the Kingdom but the spouse is not qualified for the O-A code visa, their marriage certificate shall also be produced as evidence. (The spouse will be considered for the Visa for Temporary Residents under the 'O' Code).

**Note:**

1. ***When you have prepared all the documents from stage 2. You then must make 3 photocopies per each of the documents.***

- 2. After you have photocopy all of the documents. You must separate the documents into four sets. Within these sets, please arrange all the documents of each copy in order from no.3 to no.7 and no.8 (if applicable) All together you will have one set of original and 3 sets of the documents*
- 3. Now with the four sets of the documents are prepared. Take them to Notary public, binding and notarized each set. (The documents must bind by Notary Public person only)*
- 4. Application fee is AUD\$225 for one year visa (Multiple entries) The process will take at least 5 working days.*

### **3.Recommendations for the Alien while staying in the Kingdom**

1. When completing the stay of 90 days in the Kingdom, the alien shall report to the competent authority and repeat it every 90 days with the immigration officer in the alien's residence area, or report to the police station in the alien's residence area if there is no immigration control there. In order to report to the competent authority by mail, the alien shall do as follows:
  - a) The Report form (To Mo 47) together with a copy of the passport pages showing the alien's photo, personal details, and the latest arrival visa stamp as well as a self addressed envelop with postage affixed, shall be forwarded, by 7 days before the due date, by acknowledgement of receipt mail to the Immigration Bureau, Sathon Tai Road, Sathon District, Bangkok 10120.
  - b) In case of conducting any following reports, the Reply Form for the previous report shall be enclosed as well.
2. At the end of the one-year stay, the alien who wishes to extend his/her stay shall submit a request for the extended period at the Immigration Bureau with the documented evidence of money transfer, or a deposit account in the Kingdom, or an income certificate, at the amount of no less than 800,000 Baht, or an income certificate plus a deposit account at the total amount of no less than 800,000 Baht a year.
3. If the alien's spouse wishes to extend his/her stay as well, the marriage certificate shall be produced.

## INSTRUCTIONS

1. One (1) original application form must be completed and submitted together with your passport together with one recent passport-sized photo.
2. The passport must be valid for at least six (6) months.
3. Type of visa issued by the Embassy:
  - a) Transit Visa - good for a 30-day stay in Thailand (For Transit purposes only)
  - b) Tourist Visa - good for a 60-day stay in Thailand (Employment Prohibited)
  - c) Non-immigrant Visa - good for 90-day stay in Thailand
  - d) Diplomatic or Official Visa - Issued to Diplomatic or Official passport holders. **An Official note from the Department of Foreign Affairs and Trade or Diplomatic Missions is requested.**
4. Visa fees must be paid in Australian Dollars by bank cheque, money order or in cash; personal cheques are not accepted.
5. A self-addressed registered envelope must be enclosed for the return of passport (if the applicant is outside the ACT area)
6. Visa fees:

Transit Visa	-	\$35 per entry
Tourist Visa	-	\$45 per entry
Non-Immigrant Visa	-	\$90 per entry / Multiple entries \$225
7. There are a number of countries that their nationals can enter Thailand without applying for a visa for tourism or transit purposes and will be allowed to enter Thailand for a certain period of time. Please check with the Embassy whether your country is listed before applying for a visa.
8. The single entry visa must be utilized within three (3) months from the date of issue. However, multiple re-entry visas may be granted upon request at the discretion of the Embassy.

## ADVICE

1. **TAX CLEARANCE CERTIFICATE:** Prior to departure, a Tax Clearance Certificate from the Revenue Department is required for aliens who have stayed in Thailand for more than 90 days and also for those who have received income from Thailand, regardless of length of stay. This requirement is however waived to certain types of aliens who enter Thailand and stay less than 30 days each time without earning any income or earning a non-assessable income provided that the total length of stay does not exceed 90 days in any calendar year. The waiver does not apply to foreigners who are actors, singers, musicians, etc., who enter the Kingdom for that purpose and to those who actually earn taxable income under the Thai Revenue Code.
2. There is no restriction on the amount of foreign exchange that may be brought into the country. However, the amount of money not exceeding US\$20,000 may be taken out upon leaving the country, unless the exceeding amount has been declared on arrival.
3. Buddha images and objects of art whether antiques or reproductions cannot be taken out of the country without permission. For further information please contact the Bangkok National Museum on 224-1370 or 224-1395.
